In accordance with the Tender invitation for Tender 2024-1 “**Development and implementation of an electronic platform for identification of systemic anomalies in public procurement**”, Regional Dialogue (hereinafter referred to as the contracting authority) issues the following

CONTRACT AWARD DECISION

The public tender for the “**Development and implementation of an electronic platform for identification of systemic anomalies in public procurement**” is awarded to the following tenderer: **EOS IT SOLUTIONS D.O.O., Županje Njive 31 a, 1242 Stahovica.**

Explanatory notes:

On the 20 November 2024, the contracting authority published the Tender invitation for Tender 2024-2 “*Development and implementation of an electronic platform for identification of systemic anomalies in public procurement*” (hereinafter referred to as public tender).

In the award procedure negotiations were not included.

By the deadline for the submission of tenders, i.e. 9 December 2024, by 11:00 CET, the following tender was received by the contracting authority:

No untimely tenders were received.

The tenders were opened on 11 December 2024 at 9:50 CET.

The contracting authority has reviewed the sole tender received, i. e. the tender of the tenderer EOS IT SOLUTIONS D.O.O., Županje Njive 31 a, 1242 Stahovica, in respect of compliance with the contracting authority's requirements set out in the tender documentation. On the basis of an examination of the tender received and its supplement, it was established that the tender does not contain any calculation errors, that the tender was submitted by a tenderer for whom there are no grounds for exclusion and that the tenderer fulfils the conditions for participation

set out in the tender documentation, that the tender meets the needs and requirements of the contracting authority as set out in the tender documentation, that the tender was received on time, that there is no evidence of collusion or corruption, that the contracting authority did not consider the tender to be abnormally low, and that the tender price was within the contracting authority's financial means available for this public tender.

The contracting authority did not rank the sole tender received according to the criterion for the selection of the most economically advantageous tender set out in the tender documentation, as this would not have influenced any different decision of the contracting authority.

In the light of the foregoing, the contracting authority evaluated the tender of the tenderer EOS IT SOLUTIONS D.O.O., Županje Njive 31 a, 1242 Stahovica, as the most economically advantageous tender for the subject procurement and took the decision as stated above.

The contract award decision is therefore justified.
