In accordance with the Tender invitation for Tender 2025-1 ("**Conducting corruption and integrity risk assessments (CIRA) in selected sectors, improving conflict of interest managing systems and advising on development of an electronic platform for identification of systemic anomalies in public procurement and oversight of public expenditures**"), Regional Dialogue is issuing a

DECISION ON AWARDING TENDER

Based on the public procurement procedure for "Conducting corruption and integrity risk assessments (CIRA) in selected sectors, improving conflict of interest managing systems and advising on development of an electronic platform for identification of systemic anomalies in public procurement and oversight of public expenditures", published on 12 June 2025, Regional Dialogue is awarding the tender to **Goran Klemenčič**, whose submitted offer meets all the conditions set in the tender documentation, with a total tender price in EUR including VAT amounting to 61.000 EUR.

Explanatory notes:

On 12 June 2025, Regional Dialogue (the Contracting Authority) issued an invitation to tender for "**Conducting corruption and integrity risk assessments (CIRA) in selected sectors, improving conflict of interest managing systems and advising on development of an electronic platform for identification of systemic anomalies in public procurement and oversight of public expenditures**", with a deadline for submission of tenders by 19 June 2025, 11:00 a.m. CET. The deadline was extended the very same day because of the technical difficulties with the stated e-mail address via notification on the website, inviting tenderers to submit the offer via another Regional Dialogue's e-mail address.

The Contracting Authority received the following offers by the deadline set forth in the Tender invitation:

a) Eligibility of offers

The Contracting Authority set out the conditions for determination of eligibility to participate in the procurement procedure (paragraph 8. *Eligibility* of the Tender invitation) and checked the offers received in terms of grounds for exclusion, conditions of eligibility for professional activities, conditions for participation as regards technical and professional competence, and personnel requirements or capability. The Contracting Authority finds the tender offer received complete, as it contains all of the completed forms and other relevant proof documents and is thus eligible from the technical point of view.

b) Performance of offers based on the evaluation criteria

Tender Invitation set forth two criteria for evaluation of received offers as described in detail in the Tender Invitation. As the sole purpose of these criteria is to select the most advantageous offer out of multiple timely and complete offers received, the Contracting Authority didn't apply them as it received only one offer, which:

- is complete,
- meets all the requirements and conditions from the Tender Invitation,
- is within the budget set by Regional Dialogue for this project.

As Goran Klemenčič's offer was both eligible and within the budget set, the Contracting Authority decided on awarding tender as stated above.
